



## EXECUTIVE ORDER NO. PCG - 56 SERIES OF 2022

AN ORDER PROVIDING GUIDELINES FOR THE ADDITIONAL BENEFITS/BONUSES IN THE FORM OF CASH TO NATIONAL OFFICIALS, BARANGAY OFFICIALS, CITY EMPLOYEES, VOLUNTEERS ASSIGNED IN THE CITY OF PASIG, OTHER ENTITIES AND ORGANIZATIONS ASSISTING IN VARIOUS SERVICES FOR THE CITY OF PASIG, FOR OTHER PURPOSES.

**WHEREAS**, Republic Act No. 7160 also known as Local Government Code of 1991 provides that, the local government unit may grant allowances and other benefits to national government officials stationed in or assigned in the city;

WHEREAS, one of the programs of the City Government of Pasig in recognition of the hard work and dedication to public service of its employees, of volunteers and various organizations and entities is the grant of incentives in order to boost the delivery of public service and as a way of giving back to deserving personnel for the dedication and hard work;

NOW, THEREFORE, I, VICTOR MA. REGIS N. SOTTO, Mayor of the City of Pasig, by virtue of the power vested in me by law, do hereby order:

**SECTION 1. GUIDELINES.** – The grant of additional benefits/bonuses in the form of cash to national officials, barangay officials, city employees, volunteers assigned in the City of Pasig, other entities and organizations assisting in various services for the City of Pasig, to wit:

**SECTION 2. APPROPRIATIONS.** – The funds to cover the implementation of this Order shall be taken from the appropriated annual budget of the city.

**SECTION 3. COMPLIANCE. –** The authority, issuance and approval hereof are subject to compliance with existing laws and COA rules and regulations on appropriations, expenditures and procurement.

**SECTION 4. REPEALING CLAUSE.** – The provisions of existing ordinances, executive orders and other issuances or portion thereof which are inconsistent herewith are hereby repealed, modified and amended.

**SECTION 5. SEPARABILITY CLAUSE.** – If any part or provisions of this Order be held unconstitutional or invalid, other parts of provisions hereof, which are not affected thereby shall continue in full force and effect.

**SECTION 6. DISSEMINATION.** – Copies of this *Executive Order* shall be furnished within seventy-two (72) hours from its issuance to the Office of the President and the Metro Manila Development Authority for their information and guidance.

**SECTION 7. EFFECTIVITY. –** This Order shall take effect immediately.
