

EXECUTIVE ORDER NO. PCG-10 SERIES OF 2023

AN EXECUTIVE ORDER RECONSTITUTING THE ANTI-DRUG ABUSE COUNCIL OF PASIG

WHEREAS, Section 16, Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991, mandates Local Government Units to pursue undertakings to improve public morals and to maintain peace and order;

WHEREAS, Department of the Interior and Local Government (DILG) Memorandum Circular 2012-94 was issued to integrate the Anti-Drug Abuse Council approach for the elimination of the proliferation and use of illegal drugs;

WHEREAS, pursuant to laws, rules, and regulations, the DILG directed all cities to organize their respective Anti-Drug Abuse Councils (ADACs) as contained in the above-mentioned Circular;

WHEREAS, the City recognizes the need to reconstitute the Anti-Drug Abuse Council of Pasig City (ADCOP) in order to aid the city in pursuit of an intensive campaign against trafficking and use of dangerous drugs;

WHEREAS, Pasig City has initiated the accreditation and selection of Civil Society Organizations (CSOs) to the Local Special Bodies on September 20, 2019;

NOW, THEREFORE, I, VICTOR MA. REGIS N. SOTTO, City Mayor of Pasig, by virtue of the powers vested in me by law, do hereby reconstitute the Anti-Drug Abuse Council of Pasig City, as follows:

SECTION 1. COMPOSITION. – The ADCOP shall be composed of the following members:

Chairperson

: Peace and Order Department Head

Vice-Chairperson

: City Vice Mayor

Members

: Eight (8) members from various Civil Society

Organizations

Liga ng mga Barangay President

SECTION 2. DUTIES AND RESPONSIBILITIES. — The Anti-Drug Abuse Council of Pasig City shall have the following duties and functions:

 a. Formulate a comprehensive Anti-Drug Plan of Action to eliminate drug affectation with corresponding targets per quarter, as included in the Peace and Order and Public Safety (POPS) Plan;



- b. Activate, Strengthen, and Ensure the functionality of the ADCOP;
- c. Ensure functionality of the Barangay Anti-Drug Abuse Councils (BADACs) and the implementation of anti-illegal drug-related programs, activities, and operations in the Barangay level
- d. Provide funds to BADACs that cannot properly fund such programs, activities, and operations, if possible;
- e. Monitor the progress of treatment and rehabilitation of persons who use drugs (PWUDS) and receive progress reports to this effect from rehabilitation centers and facilitate the release of patients from the rehabilitation centers and to their parents / family;
- f. Strengthen legal research and work in aid of legal reforms to provide stronger and more weapons that can be wielded in the anti-illegal drug campaign; and
- g. Monitor the submission of regular reports of the BADACs on the anti-drug abuse campaign activities in their respective barangays

SECTION 3. TERM OF OFFICE. – The members of the ADCOP shall retain their designations as such until June 30, 2025 or until qualified successors have been chosen.

SECTION 4. ADCOP SECRETARIAT. – There shall be an ADCOP Secretariat to be voted by, among the Council Members. The Secretariat head shall handle the administrative and technical activities of the Council. Specifically, the Secretariat shall perform the following functions:

- a. Prepare plans and projects for consideration of the ADCOP;
- Coordinate with various sectors in their plans of action against drugs ensuring their consistency with the Anti-Drug Abuse program of the City;
- c. Supervise, direct, and monitor for the Council's Implementation of approved policies and projects; and
- d. Undertake liaison and coordination activities with appropriate agencies of the government and provide a forum for interdisciplinary dialogue and deliberation of major issues and problems regarding anti-illegal drugs.

SECTION 5. REPEALING CLAUSE. – All other orders, issuances, memorandums, rules or regulations or parts hereof inconsistent herewith are hereby repealed, amended, or modified accordingly.

SECTION 6. DISSEMINATION. – Copies of this Executive Order shall be furnished within seventy-two (72) hours from its issuance to the Office of the President and the Metro Manila Development Authority (MMDA) for information and guidance, pursuant to Sec. 455(1)(xii) of the Local Government Code of 1991, as amended.



SECTION 7. EFFECTIVITY. – This order shall take effect immediately.
