



EXECUTIVE ORDER NO. PCG-44 SERIES OF 2023

AN ORDER SUPPLEMENTING EXECUTIVE ORDER NO. PCG-43, SERIES OF 2023, AND FOR OTHER PURPOSES

WHEREAS, Executive No. PCG-43, Series of 2023, was issued for the purpose of providing guidelines for the additional benefits or bonuses in the form of cash to national officials, barangay officials and employees, city volunteers assigned in the City of Pasig, other entities and organizations assisting in various services for the City;

WHEREAS, there are numerous national government agencies assigned in the City which are also deserving for the grant of the above-mentioned benefits and bonuses;

NOW, THEREFORE, I, VICTOR MA REGIS N. SOTTO, Mayor of the City of Pasig, by virtue of the power vested in me by law, do hereby order:

SECTION 1. GRANT OF ADDITIONAL BENEFITS. — The grant of additional bonuses in the form of cash to the following national government officials:

RTC AND MTC JUDGES	-	PHP5,000.00
RTC AND MTC PERSONNEL	_ =	PHP3,000.00
CITY PROSECUTOR AND HIS ASSISTANTS	=	PHP5,000.00
OFFICE OF THE CITY PROSECUTOR'S PERSONNEL	_	PHP3,000.00
CITY CHIEF OF POLICE, PNP	-	PHP5,000.00
LAWYERS, PAO	-	PHP5,000.00
PAO PERSONNEL	-	PHP3,000.00
DISTRICT SUPERVISORS, COMELEC	-	PHP5,000.00
COMELEC PERSONNEL		PHP3,000.00
CITY DIRECTOR, DILG	=	PHP5,000.00
DILG PERSONNEL	-	PHP3,000.00

Provided, that the abovementioned personnel must have rendered at least four (4) months of service as of 31 October 2023.

SECTION 2. SUPPLEMENTING SECTION 2 OF EXECUTIVE ORDER NO. PCG-43. — In the event that the first and second classifications of barangay elected and appointed official or employee as provided in Section 2 of said Executive Order failed to serve the complete period as stated therein, the last person who occupied such position shall be entitled to the additional bonus provided that he or she had rendered at least two (2) months of service as of 30 October 2023.

SECTION 3. APPROPRIATIONS. – The funds necessary to implement this Order shall be chargeable against any available funds in the City Treasury subject to existing rules and regulations of the Commission on Audit.

SECTION 4. REPEALING CLAUSE. – All orders or portions of orders in conflict with this Order, or inconsistent with the regulations of this Order, are hereby repealed to the extent necessary to give this Order full force and effect.





SECTION 5. SEPARABILITY CLAUSE. – If for any reason, any section or provision of this Order is held unconstitutional or invalid by competent court, such judgement or action shall not affect or impair the other sections or provisions hereof.

SECTION 6. DISSEMINATION. – Copies of this *Executive Order* shall be furnished within seventy-two (72) hours from its issuance to the Office of the President and the Metro Manila Development Authority for their information and guidance.

SECTION 7. EFFECTIVITY. - This Order shall take effect immediately.
