



## EXECUTIVE ORDER PCG NO. 02 SERIES OF 2024

AN ORDER SUPPLEMENTING EXECUTIVE ORDER PCG NO. 10, SERIES OF 2023, ENTITLED: "RECONSTITUTING THE ANTI-DRUG ABUSE COUNCIL OF PASIG", FOR OTHER PURPOSES.

**WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, mandates local government units to pursue undertakings to improve public morals and to maintain peace and order;

WHEREAS, in Joint Memorandum Circular No. 2018-01 dated May 21, 2018, the Department of Interior and Local Government and the Dangerous Drugs Board provided the implementing guidelines on the functionality and effectiveness of Anti-Drug Councils for further structural consistency and build a comprehensive monitoring and reporting system of local government units;

WHEREAS, Executive Order PCG No. 10, Series of 2023, as amended, reconstituted the Anti-Drug Abuse Council of Pasig City (ADCOP) in order to aid the city in pursuit of an intensive campaign against trafficking and use of dangerous drugs;

WHEREAS, there is a need to expand the membership of the ADCOP to include Regional Trial Court and Municipal Trial Court Judges pursuant to the said Joint Memorandum Circular;

NOW, THEREFORE, I, VICTOR MA REGIS N. SOTTO, City Mayor of Pasig, by virtue of the powers vested in me by law, do hereby that:

**SECTION 1. ADDITIONAL MEMBERS. —** The following shall be included as members of ADCOP:

Member

Judge

Regional Trial Court

: Judge

Municipal Trial Court

**SECTION 2. GRANT OF HONORARIUM.** – In recognition of the efforts spent by its members, the grant of honorarium to the members of ADCOP is thus proper taking into consideration their invaluable contribution to the City, subject to the following amounts and conditions:

- a. Three Thousand Pesos (PHP 3,000.00) per quarter for the Vice-Chairperson;
- b. Two Thousand Pesos (PHP 2,000.00) per quarter for every member; and
- c. One Thousand Five Hundred Pesos (PHP 1,500.00) per quarter for the Secretariat.







## Provided that:

- They are actually performing the duties and responsibilities of a member of ADCOP during its quarterly meeting pursuant to Executive Order PCG No. 10, Series of 2023, as amended; and
- 2. The period of entitlement to honorarium shall be coterminous with the duration the actual assignments of the member.

**SECTION 3. APPROPRIATIONS.** – The funds necessary for the implementation of this Order shall be chargeable against any available funds in the City Treasury subject to existing COA rules and regulations.

**SECTION 4. REPEALING CLAUSE. –** All issuances which are inconsistent with or contrary to the provisions of this Order are hereby amended or repealed accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** – If for any reason, any section or provision of this Order is held to be unconstitutional or invalid by competent authority, such as judgement or action shall not affect or impair the other sections or provision hereof.

**SECTION 6. EFFECTIVITY.** – This Order shall take effect immediately.
