



EXECUTIVE ORDER PCG. NO. <u>08</u> SERIES OF 2024

AN ORDER CREATING AN INTERIM TRANSITION COMMITTEE TO OVERSEE THE CONVERSION OF THE PASIG CITY CHILDREN'S HOSPITAL INTO THE PASIG HOPE MEDICAL CENTER, AND FOR OTHER PURPOSES

WHEREAS, on December 15, 2022, the Pasig City Government's Sangguniang Panlungsod passed Ordinance No. 49, converting the Pasig City Children's Hospital-Child's Hope (PCCH) from a Level 2 Specialty Hospital into a Level 2 General Hospital known as the Pasig Hope Medical Center;

WHEREAS, the conversion came after the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD) approved the PCCH's proposal to be transformed into a general hospital in accordance with the Philippine Health Facility Development Plan 2020-2040;

WHEREAS, prior to the conversion, the PCCH in 2020, pursuant to Executive Order No. PCG-16 was already converted, albeit temporarily, into the Pasig City COVID-19 Referral Center, allowing Pasig City to treat more COVID-19 patients, reduce patient cross-contamination, and expand the hospital's other services that catered to the Pasigueños' growing health, medical, and hospital needs, subject to DOH guidelines;

WHEREAS, to sustain the momentum of the conversion into the Pasig Hope Medical Center, an interim transition committee comprised of the most qualified personnel is required to oversee and ensure the effective conclusion of the process, including the expansion of its hospital and medical services;

NOW, THEREFORE, I, VICTOR MA REGIS N. SOTTO, City Mayor of Pasig, by virtue of the powers vested in me by law, do hereby order that:

SECTION 1. CREATION OF INTERIM COMMITTEE. – The Pasig Hope Interim Transition Committee is hereby created with the following objectives:

- Develop a transition plan to guide the Pasig Hope Medical Center's expanded services faithful to the requirements of Department of Health's (DOH) Health Facilities and Services Regulatory Bureau (HFSRB) and in line with the country's thrust towards the fulfillment of Universal Health Care;
- 2. Create a transition proposal for areas of responsibilities with proposed staffing patterns, budget, equipment, additional infrastructure and timetable of administrative tasks;
- 3. Be responsible for screening of applicants, scheduling of interviews, reference checks and drafting recommendations for the board for credentialing process;
- 4. Evaluate and review job descriptions, duties and responsibilities of existing personnel to ensure proper utilization of human resources; and

SECTION 4. SEPARABILITY CLAUSE. – In the event that any provision in this Order or any part hereof is declared invalid, illegal or unconstitutional, the provisions not hereby affected shall remain in force and effect.

SECTION 5. REPEALING CLAUSE. – All orders, rules and regulations and other issuance or parts thereof that are inconsistent with the provisions of this Order, are hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY. – This Order shall take effect immediately.
