



EXECUTIVE ORDER PCG NO. 13_ SERIES OF 2024

AN ORDER REORGANIZING THE MEMBERSHIP OF THE ANTI-DRUG ABUSE COUNCIL OF PASIG, FOR OTHER PURPOSES.

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, mandates local government units to pursue undertakings to improve public morals and to maintain peace and order;

WHEREAS, in Joint Memorandum Circular No. 2018-01 dated May 21, 2018, the Department of Interior and Local Government and the Dangerous Drugs Board provided the implementing guidelines on the functionality and effectiveness of Anti-Drug Councils for further structural consistency and build a comprehensive monitoring and reporting system of local government units;

WHEREAS, Executive Order PCG No. 10, Series of 2023, as amended, reconstituted the Anti-Drug Abuse Council of Pasig City (ADCOP) in order to aid the city in pursuit of an intensive campaign against trafficking and use of dangerous drugs;

WHEREAS, there is a need to reorganize the existing membership of the ADCOP in order to adhere to the pertinent issuances of the national government agencies;

NOW, THEREFORE, I, VICTOR MA REGIS N. SOTTO, Mayor of the City of Pasig, by virtue of the powers vested in me by law, do hereby order that:
